**Pacific Alliance Bank Announces period ending March 31, 2014 Results**

Pacific Alliance Bank (PFBN) operating results for the period ending March 31, 2014 are as follows:

- The Bank posted a net income of \$124 thousand or \$0.06 per share in the 1st quarter of 2014, compared with a net income of \$309 thousand or \$0.14 per share for the same period in 2013. The Bank posted a net income of \$49 thousand or \$0.22 per share for the month ended, March 31, 2014, compared with a net income of \$107 thousand or \$0.05 per share for the same period in 2013.
- Total Assets increased by \$39.4 million to \$174.5 million, a 29.2% growth from \$135.1 million at March 31, 2013.
- Loans outstanding increased by \$32.0 million to \$127.0 million, a 33.6% growth from \$95.1 million at March 31, 2013.
- Deposits outstanding increased by \$22.8 million to \$136.9 million, a 20.0% growth from \$114.1 million at March 31, 2013.
- The Bank provided \$80 thousand for loan loss provision in the 1st quarter, allowance for loan losses to total gross loans is at 2.12% as of March 31, 2014.
- There are no impaired loans on the SBA loan unguaranteed portion in the 1st quarter. As of March 31, 2014, Non-accrual loans totaled \$4.9 million.
- The Bank continues to be categorized as “well-capitalized” under the regulatory guidelines, with Tier 1 leverage capital ratio of 10.3%, Tier 1 risk-based capital ratio of 12.2%, and Total risk-based capital ratio of 13.5%.
- The Bank’s ROA as of March 31, 2014 is 0.31% and ROE is 2.97%. For the same period in 2013, ROA is 0.93% and ROE is 7.91%.
