Pacific Alliance Bank Announces Period Ending September 30, 2017 Results

Pacific Alliance Bank's (PFBN) unaudited operating results for the period ending September 30, 2017 are as follows:

- The Bank posted a net income after income taxes of \$1,721,000 or \$0.55 per share for the 9-months ended September 30, 2017, compared with a net income of \$1,671,000 or \$0.55 per share for the same period in 2016.
- Total Assets decreased by \$11.2 million to \$264.45 million, a -4.08% decreased from \$275.69 million at September 30, 2016.
- Gross Loans outstanding decreased by \$488,000 to \$198.69 million, a -0.25% decreased from \$199.18 million at September 30, 2016.
- Deposits outstanding decreased by \$13.94 million to \$229.29 million, a -5.73% decreased from \$243.22 million at September 30, 2016.
- No loan loss provision was provided in the period ended September 30, 2017. Allowance for loan losses to total gross loans was at 1.90% at September 30, 2017.
- There were no impaired loans on the SBA loan unguaranteed portion at September 30, 2017 and non-accrual loans totaled \$123,000.
- The Bank continues to be categorized as "well-capitalized" under the regulatory guidelines, with common equity tier 1 capital ratio of 14.68%, tier 1 capital ratio of 14.68%, total capital ratio of 15.93% and tier 1 leverage ratio of 12.81%.
- The Bank's ROA as of September 30, 2017 was 0.88% and ROE was 7.26%. For the same period in 2016, ROA was 0.87% and ROE was 7.83%.
