Pacific Alliance Bank Announces Third Quarter 2025 Operating Results

SAN GABRIEL, CALIFORNIA – **Pacific Alliance Bank (OTC: PFBN)** reported unaudited operating results at and for the period ending September 30, 2025. The highlights are as follows:

- The Bank reported after tax net income of \$2.74 million or \$0.85 per share for the 9-months ended September 30, 2025, compared with a net income of \$1.51 million or \$0.47 per share for the same period in 2024.
- Total assets increased by \$47.94 million to \$442.36 million, a 12.15% increase from \$394.43 million at September 30, 2024.
- Gross loans outstanding increased by \$33.22 million to \$326.52 million, a 11.33% increase from \$293.30 million at September 30, 2024.
- Total deposits increased by \$50.89 million to \$358.77 million, a 16.53% increase from \$307.88 million at September 30, 2024.
- The allowance for credit losses was \$5.23 million at September 30, 2025. The allowance for credit losses to total gross loans was 1.60% at the end of the third quarter of 2025.
- The Bank continues to be categorized as “well-capitalized” under the regulatory guidelines with common equity tier 1 capital ratio of 15.52%, tier 1 capital ratio of 15.52%, total capital ratio of 16.77%, tier 1 leverage ratio of 13.27% and community bank leverage ratio (CBLR) of 13.27%.
- As of September 30, 2025, the Bank’s ROA was 0.85% and ROE was 6.69%. For the same period in 2024, ROA and ROE were 0.53% and 3.82%, respectively.
